The Borrower named above agrees:

1. They have read, understood, and accepted the terms stated in the User policy.
2. The address and phone number the library has on file is correct and up-to-date.
3. The borrower agrees to return the LOT items on time and understands they will be charged a fine of \$1.00 per day for overdue items. Their card will be suspended when the overdue fine has reached \$10.00. Once item is returned and fine is paid in full, the card will be reactivated.
4. All items lent by the LOT are the property of BPL. Only the Borrower is authorized to use/operate these items. The Borrower shall not permit the use of said items by any other person.
5. The borrower agrees they are responsible for the proper use and care of the LOT item and understands they may be charged for any item damaged (beyond normal wear/tear), destroyed or lost.
6. The borrower agrees that BPL is not responsible for any manufacturing defects in quality of workmanship or materials inherent in any borrowed item.
7. The borrower agrees that if any LOT item becomes unsafe or in a state of disrepair, the borrower will immediately discontinue use of the item and return it to the library.

Informed Consent Form For Equipment

In consideration of my use of the equipment lent out by the Bloomfield Public Library through its Library of Things program ("Equipment"), I hereby voluntarily release, discharge, waive, and hold harmless, on behalf of myself, my heirs, executors, administrators, and assigns, the Bloomfield Public Library ("Library") and its employees, officers, and agents, from any loss, damage, or injury to persons or property arising from the Equipment, whether arising through the Library's negligence or imposed by law. In no event shall the Library be liable to me for indirect, consequential or special damages, including without limitation lost use, revenue or profits. I agree to indemnify and hold the Library and its employees, officers, and agents, harmless from and against all liabilities, claims, actions, proceedings, damages, losses, costs and expenses, including attorneys' fees, for all injuries or death of any person, or damage to any property occurring or arising from or connected with, directly or indirectly, my possession, use, and return of the Equipment. No warranties, expressed or implied, including without limitation: suitability, durability, fitness for a particular purpose, condition, or quality have been made by Library, directly or indirectly in connection with the Equipment. I am borrowing the Equipment "as is." I acknowledge that I have examined the Equipment and that its condition is acceptable. I agree to surrender the Equipment to the Library in as good order and condition as when received, except for reasonable wear and tear resulting from proper use, and if returned unclean, I may be charged a reasonable cleaning fee. I agree to keep and maintain the Equipment in good condition, use it in a careful and proper manner and comply with all applicable laws and regulations. I understand that the Library does not provide supervision or instruction for the use of the Equipment. I understand and acknowledge that the use of the Equipment involves risk of serious injury, including permanent disability and death. I agree to refrain from using any Equipment in a manner inconsistent with its intended design and purpose. I have read this Liability Waiver and Informed Consent Form and sign it voluntarily. I understand that I am giving up substantial rights by signing it.
